6. That the school shall submit current year annual return in district office within 60 days.
7. That the school shall comply with the orders/guidelines of DoE and Judicial pronouncement w.r.t. utilization/maintenance of school funds.
8. That the school shall comply with the orders dated 07.11.2017/guidelines of DoE and Judicial pronouncements w.r.t. safety of the students and shall take all necessary steps to this effect.
9. That the school shall appoint one another special educator within 60 days.


