8. The school authority shall run school on ground floor and 1<sup>st</sup> floor only as per the Fire Safety Certificate dated 04.10.2023 issued by Delhi Fire Service.
9. That the school shall observe the relevant provisions of RTE Act, 2009 DSEAR 1973 and directions/ instructions issued by the Department from time to time.
10. That the school shall comply with the relevant orders/guidelines of DoE and judicial pronouncements w.r.t. utilization/maintenance of school's funds.
11. That the school shall comply with the orders dated 07.11.2017 guidelines of DoE and judicial pronouncements w.e.t. safety of students and shall take all necessary steps to this effect.
